

1 **TRANSCRIPT OF TAPED INTERVIEW OF FRANSICO GOTAY**
2 **CONDUCTED BY DETECTIVE TALTON**
3 **CASE NUMBER 06-100229**

4
5 **(DETECTIVE TALTON)**

6 A Down, I tried to stop the whole shit, the guy hits me.

7 Q Okay, stop, okay can, can you, go just a little slower for me. So you guys were
8 actually inside the Doll House?

9 A I was already outside.

10 Q Okay.

11 A I really don't know what happened inside.

12 Q Okay.

13 A I was already in the car waiting for my friends to come out the club.

14 Q Okay.

15 A Basically what happened was when they came out, him and the guy started
16 arguing, I don't know what the hell happened.

17 Q What, what about this guy, have you ever seen him before?

18 A Never.

19 Q Is, is he white, black, Spanish?

20 A He looks black or Hispanic, one or the other.

21 Q Okay.

22 A He was dark skin like me.

23 Q Okay, so it was him and your friend?

24 A That got into the argument, the guy that died.

25 Q Who was your friend, his name?

1 A William Troy.

2 Q William Troy. Now you, now the car was parked in the parking lot of the, of the

3 uh, of the Doll House, right?

4 A Uh huh (Affirmative)

5 Q And these guys were standing outside of the car?

6 A Me and my friends were outside of the car. We were getting into the car.

7 Q Okay.

8 A The guy gets out of the car, him and his girlfriend, they got outta the car, my

9 friend and him start arguing. Next thing I know, my friend falls to the floor. So I

10 try to break up the bullshit, stop the fight, you know.

11 Q Okay.

12 A Next thing I know, me and my friend, we're laying on the floor. I blacked out from

13 there.

14 Q Who was the person that stabbed you?

15 A The guy that was driving that car, that Acura.

16 Q Okay there was a Acura car?

17 A There was a guy in a Acura.

18 Q Okay.

19 A My friend was the one that died.

20 Q Okay.

21 A Basically.

22 Q Yeah. So the, okay let me ask you this, how many guys actually stabbed

23 somebody?

24 A No it was just him.

25 Q Okay it was just that one, one guy?

1 A Just that one guy.

2 Q Was there anyone else with him, be, besides the girl.

3 A Just him and the girl, that's it.

4 Q Okay. Hold on one second, okay man.

5 (Conversation on Nextel)

6 Q So you guys go to, okay, so you guys come outta the club, you go into the

7 parking lot and you start to get into your car. And then that time you see William

8 Troy, whose your friend, arguing with this, this guy.

9 A Basically.

10 Q Okay and then from that, now did you see him stab.

11 A No, I, I, I didn't, I see William fall to the floor.

12 Q Okay.

13 A I didn't know he had a knife in his hand.

14 Q Okay.

15 A So all I know is that, like I went to the guy to try to break up the shit, you know

16 relax, you know what I mean.

17 Q Yeah.

18 A So next I know dude, I thought he punched me at first. I didn't know he, he

19 stabbed me.

20 Q Okay.

21 A I had no idea that he stabbed me. All I know is that I fell to the floor and I

22 blacked out.

23 Q Okay. Gotta...

24 **(UNKNOWN MALE)**

25 Let me numb him up real quick.

1 (DETECTIVE TALTON)

2 Q Okay, go ahead.

3 (UNKNOWN MALE)

4 Let it work and you can sit and talk to him.

5 (Pause)

6 (DETECTIVE TALTON)

7 Q See if you can wipe your mouth up off just a little bit for me okay.

8 A Yeah, I don't want no more blood on me.

9 Q I understand.

10 A Nall I understand.

11 Q He man I understand you're hurt pretty bad, okay. Now when this guy stabbed
12 you, where did he stab you?

13 A The chest and the face.

14 Q He stabbed you in the left hand side, the left side of the chest and the face.
15 Where at in the face?

16 A (Inaudible)

17 Q Okay, all right. So he stabbed you right next to the nose there?

18 A (No audible response)

19 Q Okay. And is this the first time you ever say this guy?

20 A Never seen him before.

21 Q Okay.

22 A He was in the club and that was it. I was outside of the club, I, I don't know what
23 expired in the club.

24 Q Okay.

25 A I don't know I don't know exactly what, what made the confrontation happen.

1 Q .Uh huh (Affirmative)

2 A All I know is when I came outta the club him and William got into a confrontation.

3 Q Okay.

4 A The guy started...

5 Q Now did, okay let me ask you this, did you see them arguing as they walked out

6 from the club?

7 A No.

8 Q Okay.

9 A It start, basically we were walking to our car and the guy got out that car to argue

10 with William.

11 Q Okay, so he was already in...

12 A The guy was already in, yeah, he was already in the car, he was with, with his

13 girlfriend.

14 Q Okay.

15 A He was ready to peel off, he was ready to go.

16 Q Okay.

17 A And there was 2 bouncers with him.

18 Q Okay.

19 A Like 2 of the attendants...

20 Q Uh huh (Affirmative)

21 A With him already.

22 Q Okay.

23 A So I guess, you know, they had some kind of altercation inside of the club cause

24 they walked the guy to his car.

25 Q So they were trying to get the guy outta there?

- 1 A Yeah exactly.
- 2 Q Okay.
- 3 A Basically. And, and the guy got out his car, parked the car and got out his car.
- 4 Q Okay.
- 5 A And...
- 6 Q And then that's when you saw them fighting together or...?
- 7 A Yeah, basically.
- 8 Q Okay.
- 9 A I seen them swinging so I, I went over there and grabbed William and I'm seeing
10 what's going on.
- 11 Q Okay.
- 12 A Next thing I know, I get hit, I fall to the floor, I black out, I don't really remember
13 after that. All I remember is holding my friend.
- 14 Q Okay.
- 15 A On the floor.
- 16 Q Okay, let me ask you a question. What about this guy who stabbed your friend, if
17 you saw him again, do you think you could pick him out of a lineup?
- 18 A He's bald headed, he's dark skin, he had a mustache, I can't pick out his
19 girlfriend but I can definitely pick him out.
- 20 Q Okay is he tall or short?
- 21 A Bout my height.
- 22 Q Okay what....
- 23 A Maybe a little bit taller.
- 24 Q What about, 5 what you think?
- 25 A Bout 5"10, 5"11.

1 Q How much does, weight, was he big, little?
2 A Maybe about 175, 180 tops.
3 Q Okay. Now did you hear, okay, did, did you have a chance to see him stab your
4 friend over here?
5 A I seen him throw like punches...
6 Q Uh huh (Affirmative)
7 A But I didn't see the actual knife.
8 Q Okay, you didn't see a knife at all?
9 A Nall I didn't see the knife at all cause I, I'm sure if I would have seen a knife, I
10 would have back up off him.
11 Q Okay.
12 A You see what I'm saying?
13 Q Yeah.
14 A I wouldn't, I wouldn't a even approached the guy, you know what I mean?
15 Q I understand.
16 A Next thing you know, you know, my friend's laying on the floor, I'm bleeding out
17 my face, I'm thinking I'm, I'm just, you know, he hit my nose, I'm thinking he just
18 punched me in my nose and maybe I'm bleeding.
19 Q Uh huh (Affirmative)
20 A But next thing I know I, I can't stop pouring blood and I look at my shirt and I'm
21 pouring blood outta chest.
22 Q Okay.
23 A So I knew something was wrong right then and there and I look up and my
24 friends laying on the floor, he got lashes all across his chest and he's bleeding all
25 over the place. And I knew he had a knife, he had to had him a knife.

1 Q Okay, not did this guy hop in his car and leave or how did that work?

2 A He hopped in his car and left and then there was a, a, a pick up truck from the

3 actual club.

4 Q Uh huh (Affirmative)

5 A That chased him.

6 Q They chased him down?

7 A Yeah.

8 Q Okay. So, so this guy was driving a Acura?

9 A Acura.

10 Q What, was it dark, light?

11 A The, the, the TL, you know, the, the, the, the coupe looking Acura. The newer

12 one.

13 Q Okay.

14 A You know like a 2006, you know the TL whatever.

15 Q Okay.

16 A And he peeled off, he didn't even have a tag, a actual tag on the car.

17 Q Where, okay was the car black or it was white?

18 A Nall it was like a, I would say like a, a blue like that blue that's on the windows

19 XP.

20 Q Uh huh (Affirmative)

21 A See that blue right above it?

22 Q Yeah, yeah.

23 A Like that, a little darker but it was about that blue, like metallic blue.

24 Q Oh okay, all right, okay. All right then man, I'll let you get sewed up here, okay.

25 And I'll probably come back and talk to you later, all right man?

1 A (No audible response)

2 Q Thanks. This was taken at ORMC in the end of our uh, the date on this
3 statement is gonna be uh, October 25, 2006 and the time now is 4:03 a.m. and
4 I'm at ORMC in 1414 Kuhl Avenue. And that was the uh, the statement of my
5 victim uh, victim number 2, his name is Fransico, I spell his last name, G O T A
6 Y. DOB of /30 or 77. I'm sorry, what?

7 **(UNKNOWN FEMALE)**

8 A Uh, here's one right here (Laughter) I'm Susan Mears...
